Umthengi uyavuma ukuthi kunelungelo lokunwetshwa kwesikimu lapho Isakhiwo esifakwa khona, ngokuvumelana Nengxenywe 25 yoMthetho 95 Wesakhiwo Esiyingxenywe ka 1986. Umthengi futhi uyavuma ukuthi lejenti Nomthengiso bamchazele ngalelilungelo ( **sula uma kungahilelekile** )

## 1. ISIMO SESAKHIWO

- 1.1 Umthengisi akanawo umthwalo wemfanelo ngokuphatelene nomonakalo Wesakhiwo, owangaphakathi noma owangaphandle, futhi ngaphezu kwalakho akanawo umthwalo wemfanelo ngokuphatelene nokuma, isimo, indlela yokwakhekha noma izinto ezifakelwe Esakhiweni. Isakhiwo sethengiswa "ngengoba sinjalo" esimweni saso samanje futhi ngokuphatelene nezimo zonke zaso. Umthengi uyavuma ukuthi njengoMthengi ujoyelene ngokugcwele Nesakhiwo futhi uyavuma ukuthi Umthengi akazange aphoqwe ukungenela lesisivumelwano ngobumeli obuqondile noma obangasese i-Lucas Real Estate noma omunye umuntu, noma egameni loMthengisi.
- 1.2 Isisimemezelo esifakelwe lapho, esiphawulwe ngokuthi "Isenezelo B" futhi esisayinwe Umthengisi, siyingxenywe yalokhu kuthengiselana. Kulokhu okuqukethwe yelesisimemezelo akukho okumelwe kubheke njengewaranti noma igaranti yanoma uluphi uhlobo eyenziwa Umthengisi. Uma kungenzeka Umthengisi engazimisele noma engakwazi ukunikeza lesisimemezelo, lokho kumelwe kuvezwe kuMthengi. Ngaphandle kwalapho kuvezwe ngenye indlela kuleliphepha lokwaziswa Umthengisi akanawo umthwalo wemfanelo ngokuphatelene nomonakalo wesakhiwo owangaphakathi noma owangaphandle ophakakama ngosuku lokuthengiselana noma ovela kamuva, noma izindleko zokulungisa noma yimuphi umonakala okungenzeka ubhekene noMthengi, isimo esiqondwayo esokuthi Isakhiwo sithengiswa njengoba sinjalo (voetstoots (ás is<sup>1</sup>)). Umthengi futhi uyavuma ukuthi ujoyelene ngokugcwele nencazelo kanye nemiphumela yalokho.
- 1.3 Noma yiliphi iphutha elikulesisivumelwano ngokuphatelene nencazelo noma isayizi yeSakhiwo ngeke ivimbele lesisivumelwano noma igunyaze othile kwabahilelekile ukuthila isinxephezelo.
- 1.4 Umthengisi kumelwe nje aphawule kuMthengi indawo yezikhonkwane noma izimpawu zeSakhiwo noma imingcele yaso futhi akhokhele izindleko zokufaka lezizimpawu uma kuyisiza esinganalutho.
- 1.5 Umthengisi akazi lutho ngezinto ezithile ezakhelwe eSakhiweni ezingekho kumapulani esikhawo abhalisiwe. Umthwalo wemfanelo wokuhlela amapulani agunyaziwe nabhalisiwe abhekene noMthengisi futhi zonke izindleko zokuthola lawo mapulani zizokhokhela uMthengisi. Lapho kuthengiswa iyunithi yesakhiwo esiyingxenywe Umthengisi uyavuma ukuthi ukunwetshwa kweyunithi kugunyaziwe Yindikima Emisiwe Namaejenti Aqondisayo futhi konke ukunwetshwa kubhalisiwe Kumcwaningi Jikelele naseMahhovisi Endawo. Uma kungenzeka ukuthi kunokunwetshwa okungabhalisiwe Kumcwaningi Jikelele Umthengisi uzoba nomthwalo wemfanelo wokubhalisa lokho kunwetshwa futhi uzokhokhela izindleko eziphatelene nakho.
- 1.6 Umthengi uqinisekisa ukuthi usibhekile isakhiwo ngokugcwele engakasayini lamaphepha, futhi unikezwe isikhathi esanele sokwenza kunjalo futhi Umthengi uyenelekseka ngesakhiwo kabanzi ngokwalakho okuvezwe kulamaphepha.
- 1.7 Isakhiwo sithengiswa ngokuvumelana nemigomo nemibandela yesakhiwo nezinye izimo okungenzeka ziphakama ngokuphatelene kulendaba. Umthengi uyaqaphela ukuthi iphepha lobunikazi besakhiwo (title deed) lingakwazi ukubekwa njengoba liyiphepha lomphakathi. Uma isayizi noma izilinganiselo zesakhiwo zichazwe ngokuyiphutha, incazelo yaso equkethwe yi-title deed yoMthengisi izosebenza futhi uma kunjalo, abahilelekile bayavuma ukuthi lokho kuzolungiswa kulesisivumelwano.
- 1.8 Uma kungenzeka ukuthi omunye kulabo abahilelekile kulesisithembiso sokuthengiselana efisa ukushintsha okuvunyelwenwe ngakho ekuqaleni futhi lokho kungamukelwe, kusho ukuthi isivumelwano sokuqala sizoqhubeka futhi ngeke kuthikameze noma kumise isivumelwano sokuqala.

 \_\_\_\_\_ ) izokhokhelwa Ummeli Odlulisela Impahla woMthengisi ("Abameli Abadlulisela Impahla") ngokuphatelene nokudlulisela egameni lomunye. Lapho ecelwa Abameli Abadlulisela Impahla, Umthengi kumelwe afake imali eyisibambiso esebenzisa ibhange eligunyaziwe elikhethwa Umthengisi ukuze athole ingxenywe yenani esele. Leyo mali eyisibambiso izofakwa Umthengi kungakapheli izinsuku ezingu-14 (ishumi nane) lapho icelwa Abameli Abadlulisela Impahla nganoma yisiphi isikhathi lapho sekufezwe zonke izimo eziphawulwe kulesisivumelwano.
- 2.3 Umthengi kumelwe anikeze ubufakazi bemali ngendlela eyenelisa Abameli Bokudlulisela Kwempahla kungakapheli izinsuku ezingu-3 (ezintathu) lapho kusayinwe iphuzu elithinta izimali ezizosetshenziselwa idiphozithi NOMA ukukhokhela inani lentengo ngokuphelele elikulesisivumelwano elingathintwa yingxenywe 6.1 noma isigaba 12.1.
- 2.4 Umthengisi uqinisekisa ukuthi inani lentengo lilingene ukukhokhela ibhondi esasele, izindleko Zamaejenti, izindleko zentela, ugesi, amanzi nezindleko ezithile ezihilelekile nokunye okuthintekayo okulindelwe Abaphathi Bendawo, izindikimba Ezimiswe noma Inhlangano Yabanikazi Bemizi.

### 3 UKUNGENA ESAKHIWENI

- 3.1 Lapho uMthengi esekhokhe zonke izimali, esayine wonke amaphepha afanele ebhondi kanye nawo kudluliselwa kwesakhiwo, futhi edluliselwa zonke izibambiso ezilindelekile, futhi efeze zonke izimo, futhi kukhishwe zonke izitifikethi Zomthetho ngokuvumelana naleziSithembiso Sokuthengiselana futhi umthengi efeze konke okulindelekile, ilungelo lokungena eSakhiweni lizonikezwa uMthengi ngesikhathi sika-12pm

\_\_\_\_\_. Uma usuku lokungena esakhiweni lingafani nelokudluliselwa kwesakhiwo egameni lalowo ongena esakhiweni, kuwukuthi Isakhiwo sisabhalise egameni lomunye umuntu, lapho kucatshangelwa isikhathi sokungena esakhiweni, uzokhokhela Ummeli Wokudluliselwa Kwesakhiwo intela ka-R \_\_\_\_\_ ngenyanga ngaphambi kokungena esakhiweni, imali izobalwa ngokwezinsuku ezithintekayo. Umthengi akumelwe asisebenzisela ukuzuza intela ngokuhlalisa abanye abantu ngaphambi kokudluliselwa kwesakhiwo egameni lakhe futhi ilungelo loMthengi lokungena esakhiweni lizonqamuka lapho kungenzeka isivumelwano sokuthengiselana simiswa ngandlela thile.

Lapho usuku lokungena esakhiweni lungafani nolokudluliselwa kwesakhiwo egameni lomuntu omusha, ngakho lowo ongena kuso kuwukuthi sisabhalise egameni lomunye kumelwe akhokhele izindleko zamanzi nogesi weSakhiwo kusukela ngosuku angena ngalo. Bobabili abahilelekile kumelwe bakhokhe lezizindloeko Kubameli Bokudluliselwa Kwesakhiwo lapho idingeka.

- 3.2 Umthengi akumelwe enze ushintsho noma yiluphi noma ukwenezela eSakhiweni singakudluliselwa egameni lakhe futhi engatholanga imvume ebhalwe phansi Umthengisi. Uma kungenzeka isivumelwano simiswe, uMthengi kumelwe aphume esakhiweni futhi asibuyisele kuMthengisi esimweni esifana naleso asithola sikuso lapho sinikezwa Umthengisi. Umthengi futhi ngeke acele Umthengisi ukuthi ambuyisele imali yoshintsho olwenziwe eSakhiweni

- 3.4 Kuvunyelwana ngokuthi ngeke kufakwe abantu ngenjongo yokuzuza intela futhi uma kungenzeka kumiswe ukuthengiselana noma kuphelelwe isikhathi ngenxa yesizathu esithile, Umthengi kumelwe aphume esakhiweni, ngalesosikhathi noma ngosuku bonke abahilelekile abavumelane ngalo ngokubhala phansi.

### 4 IZINZUZO NENGOZI

Izinzuzo nengozi ngokuphathelele Nesakhiwo kuzodluliselwa kuMthengi lapho isakhiwe sidluliselwa kuye futhi ngalolosuku uMthengi uzobhekana nomthwalo wezindleko zezindleko, intela noma izinkokhelo ezithinta Isakhiwo. Inani elikhokhwe kusengaphambi kokudluliselwa kwesakhiwo lizoqondiswa ngokwesimo. Umthengisi uzogcina umshwalense Wesakhiwo ongashintshiwe kuze kube yilapho isakhiwo sidluliselwa kuMthengi futhi lapho kufika lolo suku uzoqala ukukhokhela lowo mtshwalense.

### 5 UKUDLULISELWA KWESAKHIWO

Isakhiwo sizodluliselwa Ummeli Wokudluliselwa Kwempahla woMthengi ngomhlaka \_\_\_\_\_ enyangeni ka \_\_\_\_\_ 20 \_\_\_\_\_ noma ngokushesha ngangokunokwenzeka ngemuva kwalokho, uma nje Umthengi efeze yonke imigomo esengxenyeni 2.1 no 2.2 futhi esayine wonke amaphepha afanele ebhondi kanye nawo kudluliselwa kwesakhiwo futhi ekhokhe zonke izindleko zokudluliselwa kwesakhiwo. Lapho ecelwa Abameli Abadlulisela Impahla Umthengi kumelwe akhokhe leyo mali futhi Umthengisi noMthengi uzosayina womke amaphepha okudluliselwa kwesakhiwo lapho ecelwa Abameli Abadlulisela Impahla. Lapho Abameli Abadlulisela Impahla becela Umthengisi kumelwe akhokhele abameli lezo zimali ezidingekayo ukuze kutholwe isitifikethi sokugunyazwa kwezindleko noma izinkokhelo ukuze isakhiwo sidluliselwe egameni lomunye.

- 5.2 Umthengisi ugunyaza Ummeli Wokudluliselwa Kwempahla ukuba athole lokho okufunwa umasipala, okuhilela noma yisiphi isikweleti sangaphambili futhi okumelwe sikhokhelwe kumasipala ngokuvumelana nengxenyeni 118(1) ne-118(3) yoMthetho 32 Wenqubo Kamasipala ka 2000. Noma iyimphi imali ekweletwa umasipala izovezwa Ummeli Wokudluliselwa Kwempahla ngokokuhlola izindleko kubaphathi bendawo futhi uma Umthengisi angagunyisi Ummeli Wokudluliselwa Kwempahla ukuze kukhokhelwe leso sikweleti kumasipala emalini yokuthengiswa kwesakhiwo, kuzobhekwa ngokuthi ushalazela isivumelwano njengoMthengisi futhi wenza ngokumelene Nengxenyeni 16 esebenzayo. Lapho Umthengi emisa ukuthengisa ngenxa yokuhluleka koMthengisi ukulungisa iphutha, Umthengisi ngeke akwazi ukuba nendlela yokulungisa isimo noMthengi emonakalweni okungenzeka wenzekile. Umthengi ngeke abe nelungelo lokubonisa nomaMthengisi emonakalweni obangelwe ukumiswa kokuthengiselana ngenxa yemigomo yengxenyeni ethile yomthetho.

### 6 IMALI YEBHONDI

- 6.1 Ukuthengiselana kungenzeka kuphela lapho Umthengi ethola imalimboleko kungakadluli usuku luka

\_\_\_\_\_ ) (noma engaphansana kwalokho eyamukelwa Umthengi) ngokwemigomo nemibandela evamise ukufakwa kwibhondi ngokwebhange. Umthengi uqinisekisa ukuthi akazi lutho okungenzeka luvimbele ibhange ukunikeza uhlelo lwezimali. Lesisimo siyobhekwa njengesifeziwe ngosuku lapho umhlinzeki webhondi ebhala phansi uhlelo lwemalimboleko (ngokoMthetho 34 Wesikweleti ka 2005) ngokuphathelele naleyo malimboleko. Ngale kwalokho uma ibhange lihoxisa imvume yemalimboleko futhi kungabangelwa isenzo, ukuhluleka ukukhokha isikweleti noma ukunganaki koMthengi, ngakho lesisivumelwano sizophelelwa isikhathi. Uma uhlelo lwemalimboleko lunganikezwa ngosuku oluvezwe ngenhla isikhathi sokuthola imalimboleko lunganezelwa ngezinye izinsuku ezingu-30 (Amashumi amathathu).

- 6.2 Umthengi uzibophezela ukwenza konke okusemandleni Omthengi ukuvunyelwa ukuboleka imali. Umthengi futhi uyavuma ukunikeza yonke imininingwane kuMhleli Webhondi kungakadluli izinsuku ezingu-7 lapho ecelwa Umhleli Webhondi. Lapho Umthengi ehluleka ukuthola ukuvunyelwa ukuboleka imali ngenxa yephutha noma ukunganaki koMthengi ngakho lesisivumelwano siyoba isibopho kuMthengi ngokombono woMthengisi. Lapho Umthengi ehluleka ukunikeza imininingwane edingekile noKwenza Isicelo Semali esifanele lapho ecelwa, Umthengi uyoba nomthwalo wemfanelo wokukhokha zonke izindleko zeEjenti noma zoMthengisi ezibangelwa ukuhluleka koMthengi ukufeza imigomo ebhekile.

- 6.3 Imigomo ka 6.1 ingeyenzuzo yoMthengi okungezeka ahoxise isimo ngokusho ngomlomo noma ngesenzo.
- 6.4 Imalimboleko aphawulwe lapho izohlelwa umhleli webhondi ezobhaliswa egameni leSakhiwo lapho isakhiwo sidluliselwa egameni lomuntu ongena kuso.
- 6.5 Ngaphambi kokufeza lesisimo, lapho Umthengi ekhetha okungayamukela inzuzo yalesisimo noma ukwamukela uhlelo lwebhange emalini evezwe eNgxenyeni 6.1 ngakho Umthengi kumelwe anikeze Ummeli Wokudluliselwa Kwempahla woMthengisi isiqinisekiso sasebhange (noma afake imali kwi-Trust Account Yommeli Wokudluliselwa Kwempahla woMthengisi) imali ephelele ngokweNgxenyeni 6.1 noma imali eyengeziwe lapho kwamukelwe ibhondi engaphansi kwenani ngokweNgxenyeni 6.1, ngokwesimo okuyiso, kungakapheli izinsuku ezingu-14 noma ukwamukela imali engaphansi yebhondi.
- 6.6 **Umthengi kumelwe aqaphele ukuthi ngokuvumelana nenqubo yokugcwaliseka kwento, lengxenywe izobhekwa njengefezekile lapho umthengi ethikameza ukugcwaliseka kwalengxenywe nganoma iyiphi indlela.**

## 7 ISITIFIKETHI SIKAGESI ESINGOKOMTHETHO

Umthengisi kumelwe anikeze Umthengi, ngokusebenzisa abameli bokudluliselwa kwempahla, Isitifikethi Sikagesi Esiongomthetho esivumelana Nomthetho Kahulumeni No.1 2920 ka 1992 kungakadluli usuku lokudluliselwa kwesakhiwo egameni lomtyengi noma lapho sicelwa abameli bokudluliselwa kwesakhiwo, kuye ngalokho okufika kuqala. Ngokuphathelene nomhlinzeki kagesi ogunyaziwe okhethwe Umthengisi ukuze ahlele isitifikethi futhi adinga ukulungisa noma ukushintsha okuthile ngaphambi kokunikeza isitifikethi, Umthengisi uzohlela ukuthi lowomsebenzi wenziwe futhi awukhokhele ngokwakhe. Isitifikethi akumelwe sifakwa usuku lwangaphambi kokwamukelwa esingaphezu kwezinyanga ezintathu (3). Uma lbhange lifuna isitifikethi esisha noma esisebenzayo Umthengisi kumelwe avumelane nalokho futhi akukhokhele njengoMthengisi.

## 8 ISITIFIKETHI SOKUSUSA ZINAMBUZANE (sula uma kungahilelekile)

Ngaphambi kosuku lokungena esakhiweni Umthengisi, ngokusebenzisa abameli bokudluliselwa kwesakhiwo, uzonikeza Isitifikethi ngokuphathelene neSakhiwo esithengisiwe, esingadluli izinyanga ezintathu (3) kusukela kulolu suku, esivela kwilungu le-South African Pest Control Association ukuze kuhlolwe zonke izingxenywe zesakhiwo ezonakaliswa izinambuzane okufaka phakathi ama-hylo trope, bajulus, Anobium Puncialum noma oxypleurus nodieri. Uma izingodo zitholakala zinezinambuzane Umthengisi uzokhokhela ukufuthwa ukuze zibulawe futhi uzoshintsha zonke izingodo okungenzeka zithintekile. Lokho kukhlola ngeke kuhlanganise okokubiyela, izindlu zamapulungwe namashedi ezingodo.

## 9 ISITIFIKETHI SOKUFAKWA KWE-GAS (Isitifikethi Somthetho)

Uma kufakelwe i-gas eSakhiweni ngakho Umthengisi, ngokusebenzisa imali yakhe njengoMthengisi, uzonikeza uMthengi, Isitifikethi Somthetho esikhishwe umuntu ogunyaziwe njengoba kuchazwe ngaphansi kwe-Pressure Equipment Regulations 2009 ngaphansi kwengxenywe 43 ye-Occupational Health and Safety Act 85 of 1993, ukuze wonke amathuluzi e-gas esakhiweni avumelane nezindingansio zompimo nokuphepha. Umthengisi uthembisa ukuthi ngeke ashintshe, afake noma asusa okufakiwe kwe-gas (kufake phakathi amabhodlela e-gas, amavalufu noma iziqondiso) ngemuva kokunikezwa kwesitifikethi. Ngokuphathelene nomuntu omiswe Umthengisi ukuze ahlele isitifikethi futhi adinga ukulungisa noma ukushintsha okuthile ngaphambi kokunikeza isitifikethi, Umthengisi uzohlela ukuthi lowomsebenzi wenziwe futhi awukhokhele ngokwakhe.

## 10 ISITIFIKETHI SOKUBIYELA NGOGESI

Uma kubiyelwe ngogesi eSakhiweni futhi nalapho Isakhiwo esizimele (okuwukuthi, esingekho ngaphasi kwesikimu sesakhiwo esiyinxenywe) ngakho Umthengisi, ngaphambi kokubhalisa ukudluliselwa kweSakhiwo kuMthengi uzonikeze uMthengi, ngokusebenzisa abameli abadlulisela impahla, ngeSitifikethi Somthetho esivumelana neZiqondiso Zemishini Kagesi (esikhiswa ngokuvumelana ne-Occupational Health and Safety Act 85 of 1993). Zonke izindleko ezihilelekile lapho kuhlelwa isitifikethi kuhlanganise nomsebenzi wokulungisa owenziwa ngaphambi kokunikeza isitifikethi kuzokwenziwa Umthengisi. Umthengisi uthembisa ukungasusi noma yikuphi okubiyele okusebenzisa ugesi.

## 11 INHLANGANO YABANIKAZI BEMIZI (sula uma kungahilelekile)
